On Tuesday, March 30, 2010

the Homewood Fire Department was dispatched to a structure fire at a single-family residence. The crews made valiant efforts but could not reach 87 year old WWII veteran Wendell H. Elias.

Ride For Boo starts September 9th

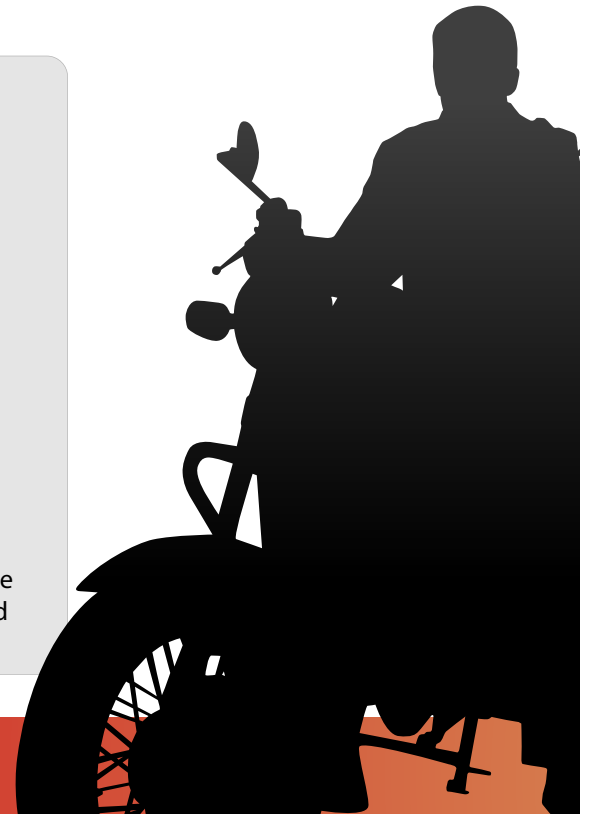

"RIDE FOR BOO" BENEFIT EVENT
RELEASE AND INDEMNIFICATION AGREEMENT

I, the undersigned, as a participant, either a driver or passenger, on my own behalf and on behalf of my heirs, personal representatives, successor and assigns, for and in consideration of the opportunity to participate in the "Ride for Boo" benefit event (hereafter "event") knowingly and expressly release, indemnify and hold harmless the sponsors, officers, directors, members, organizers, and their respective agents and designees (hereafter "released parties") from any and all claims and demands, rights and causes of action of any kind, whatsoever, which I now or at any time hereafter may have against each and every one of them, individually, collectively, jointly and/or severally, or otherwise, in any way resulting from, arising out of or in connection with my participation in the event.

I hereby acknowledge and agree that the released parties bear no responsibility, whatsoever, for the operation, licensing, maintenance of any participating vehicle or for the imputation or provision of any knowledge or awareness of any local, state, intrastate, interstate and federal laws, rules and regulations with respect to my operation of, presence in, control over or otherwise, as a passenger, driver or otherwise, any motor vehicle by and through which I participate in any aspect of the event.

This release and indemnification agreement (hereafter "release") extends to any and all claims I have or later may have against the released parties with respect to the event or with respect to the conditions, qualifications, instructions, rules, procedures, guidelines or information disseminated or otherwise under which the event is conducted or from any other related cause. I understand that this means that I agree not to sue or bring any civil, equitable or other concomitant cause of action against any of the released parties for any injury, harm or damages resulting to myself, as participant, or my property, including but not limited to any participating vehicle, arising from or in connection with any aspect of the event.

In signing this release, I further acknowledge that I am 18 (eighteen) years of age or older, and that I have read this release and that I fully understand it, agree to bound by it and have relied upon no extraneous agreements, statements, interpretations or otherwise from any of the participants that would limit its effect.
